Conditions of Entry

How to enter:

Hit the **Enter competition to win a free family pass to the SA Aquatics and Leisure Centre!** button on the Active Recreation page of the Office for Recreation and Sport website and complete the survey.

Competition terms and conditions:

Entry

1. Entry to this promotion is deemed acceptance of these Conditions of Entry by each entrant. Entrants must be aged 18 years or over. Proof of age may be required.
2. To enter the Competition, entrants must complete the survey by the closing date.
3. Only one entry per person is permitted per competition.
4. Employees of the Office for Recreation and Sport (ORS) and their immediate families are ineligible to enter the Competition.
5. The SAALC free family passes competition commences on **Friday 2/2/18 and closes at 10am CST on Friday 16/2/18.**
6. Entrants must be residents of South Australia at the time of claiming the prize.
7. Entries will be deemed to be accepted at the time of receipt.
8. Entries must be received during the promotional period. Department of Planning, Transport & Infrastructure (DPTI) and ORS accept no responsibility for late or misdirected entries.

Personal information

9. By entering the competition and accepting the Conditions of Entry, you accept that DPTI and ORS may use your personal details for the purpose of conducting the competition, including the use of your name in promotional formats.
10. By entering the competition, you give ORS permission to contact you via email or phone if you are a winner of the competition.
11. 15. The winners will be notified via email and phone.

16. If ORS is unable to contact the winners directly, the winners must make contact with ORS via email orsparticipation@sa.gov.au or phone on 1300 714 990 within 2 working days to arrange collection of the prize.

17. The pass must be collected from the Office for Recreation and Sport (27 Valetta Road, Kidman Park) between 9am and 5pm and by 4pm on **Friday 23/2/18**. Should the tickets not be collected, a re-draw will take place.

18. The promoter shall endeavour to contact the winners within two hours of the prize draw. In the event that the winners cannot be contacted by **5pm on Monday 19/2/18**, alternate winners will be selected on the basis of the criteria specified and the original winner will forfeit any prize.
