You will be requested to undertake a 100 point identity check as a part of this process which may require you attending the Office for Recreation and Sport to complete. If you are unable to do this in normal business hours please contact the Boxing and Martial Arts Compliance Officer to make alternate arrangements. See the SA Police website (www.police.sa.gov.au) for more information on documents required for a 100 point check.

The certificate must be no more than three (3) months old preceding the date of lodgement of the licence application.

To obtain this certificate you need to apply directly to the South Australia Police, or a CRIMTRAK registered agency.

IMPORTANT INFORMATION

Persons not normally resident in South Australia may not apply to be registered in South Australia as a Coach/Trainer.

Victoria is the only state which currently requires that all trainers with professional contestants taking part in a professional boxing or combat sports contest must be licenced.
